

“#BUCKSKIDSGOBIG” RAFFLE

2019 OFFICIAL RULES:

Contest is only open to residents of continental United States who are 18 years of age or older or have consent from their parent/guardian to participate.

1. SPONSORS: The Sponsor of the “BucksKidsGoBig” Raffle is the Bucks County Children’s Museum (BCCM) ("Sponsor" here forth), 500 Union Square Drive New Hope, Pa 18938, telephone: (215) 693-1290, e-mail: info@buckskids.org.

2. CONTEST PERIOD: The Contest begins at 12:01 a.m. on Saturday June 1, 2019, and ends at 11:59 p.m., on Sunday September 1, 2019 (the "Contest Period").

3. ENTRY: No purchase is required to enter the Contest. To enter, users must post a photo which includes the Bucks County sign located at the museum entrance on Instagram utilizing the hashtag **#BucksKidsGoBig**. You may post multiple times, but each entrant only gets one chance to win. All entries must be made via Instagram. No other form of entry is permitted and will not be accepted. All entries must be received during the Contest Period. Sponsor(s) assumes no responsibility for any problems or technical malfunction of computer on-line systems, servers or providers, computer equipment, software, failure of any entry to be received by Sponsor(s) on account of technical problems or traffic congestion on the Internet or at any Web site, or any combination thereof.

Entrant is responsible for all fees charged by any Internet Service Provider. Sponsor(s) are/is not responsible or liable for any lost, stolen, mutilated, incomplete, illegible, misdirected or non-delivered entries. Upon their receipt, entries become the property of Sponsor(s) and will not be returned. Entries are void if received through illegitimate channels or are the results of fraud.

By submitting photography utilizing the hashtags **#BucksKidsGoBig** users consent to allow sponsor(s) usage of the photo for editorial or promotional purposes, promoting BCCM.

Only entries which include the Bucks County sign located outside the museum’s front door will be considered. On or about Wednesday, September 11, 2019, Sponsor will notify the winner by commenting on the posted photo. Each entrant is responsible for monitoring his or her Instagram account for notification and receipt or other communications related to this contest. Any prize notification which is returned as undeliverable, is otherwise unsuccessful, or is not accepted within 72 hours will result in disqualification and selection of an alternate winner. Only the prizes set forth below will be awarded. Sponsor reserves the right to change the winner selection method at its sole discretion.

Winners will receive the allotted prize within 30 days of notification and acceptance of the prize.

5. PRIZES:

5 randomly chosen raffle winners will each receive a "Bring 4 Prize Pack" consisting of 4 complimentary general admission tickets to the Bucks County Children's Museum and a Bucks County Children's Museum t-shirt.

Value of the prizes vary but do not exceed \$32. Prize is transferable. Cash redemption, exchange or substitution is not allowed.
